Schools are advised of this responsibility on pre-event correspondence.Staff are first aid trained.An appropriately stocked first aid kit is present at each event.Staff aware of where additional first aid can be found at the main reception.Injured participants/School Staff/ GAP Staff not moved until inspected by school staff/emergency services as necessary.Pre-existing medical conditions must be notified by school staff to GAP staff.Any medication required is with the person who requires it, e.g. asthma inhaler.Mobile phone to be available to summon prompt medical assistance without leaving the casualty.No chewing gum permitted during the competition.Sports equipment is checked. All participants arrive with a staff member from their school and registered. All participants are collected at end of the activity by staff member not parents. Contact details for all schools available on the day. Schools are responsible for ensuring the safe collection of children in their care. Participants to be supervised at all times and to be made aware that they must remain with the adult responsible for them at all times. Participants not to go outside of the competition and clubhouse areas. All activities are within an identified area which is communicated to staff and participants. Schools should keep a participants' list as this will be used to undertake a roll call at the assembly point. A mobile phone is available to contact emergency services. Stadium / Athletics Track a. Collision, impact, friction injuries (Tarmac/Walls) b. Trip, slip, collision, injury c. Staff and session participants being struck by vehicles	<ul style="list-style-type: none"> Pre session inspection of the competition session area by staff to identify and remove or clear avoidable hazards or obstructions where it is safe to do so. Where removal is not safe, report the hazard to the centre manager / caretaker. If hazards cannot be removed an alternate competition / event / course / session area should be found or the competition / event / course / session area reduced by excluding the hazards with cones or similar markers. Staff ensure space is appropriate to activity and number of participants. Activities appropriately spaced to reduce risks of collision. All equipment stored away from competition / event / course / session area when not in use. Replacement and repair of equipment is acted upon promptly when reported. Improvised equipment is not used if it compromises safe practice. Participants are made aware of hazards and possible risks. Competition / event / course / session surfaces are in good condition with no loose material, oil or significant amounts of water. Competition / event / course / session areas and equipment are suitable size for age and ability of those involved. Vehicular access is restricted. Car Parking areas are separate from those used for participants to take part in the competition. Netting is maintained in good condition. Competition / event / course / session areas are sited to prevent risk of running into walls or other obstacles. A fire assembly point is established at each site and all staff and participants know where this is. Any spectators remain in the designated seating, separate from the athletes and staff. This outside the perimeter of the athletics track. No photographs to be taken by spectators.
